

Reasons for establishing a quality system in the organization

- **Financial** – cost management
- **Business** - proof to the customer that organization deals with quality
- **Technical** - the effort to standardize processes and methodologies
- **External** - international status
- **Internal** - an effort to communicate the principles of quality to all employees of the organization

Objective - to obtain the Certificate of Quality

- **Management decision - a requirement, need or expectation to be determined**
- **Systems analysis - defining the areas for processing and document modification**
- **Processing of documentation, procedures and instructions, creating the first draft**
- **Review and approval of the draft documentation prepared by management**
- **Certification audit, correcting deficiencies**
- **Certification - continuing improvement, continuing internal audits, corrective actions, management reviews and control audits**




Development in the numbers of farm animals in the Slovak Republic




Development of enrolment % in PR according to farm animal species




Development of the numbers in PR by farm animal species - cows




Cattle farms in PR by main breed in 2010



Development of the numbers in PR by farm animal species - ewes




Ewes farms in PR by main breed in 2010


